Open letter

Point of view of the Jewish Community of Caransebes regarding to the statements of Mr. Ion Marcel Vela, Minister of Internal Affairs of Romania

Dear Minister Ion Marcel Vela,

The members of the Jewish Community of Caransebes took note of your statements, during the show broadcast by Express de Banat on Friday, September 25, 2020, regarding the Jewish community, in which you mentioned, among other things, "the pavement placed in the backyard of the only Jew from Caransebes" and you have drawn a parallel with works at other places of worship of other denominations. We believe that this information is not only incorrect, but, being launched on a public channel of communication, is also becoming biased and we want to offer, in the following, a series of clarifications, for the correct information of the public opinion:

- The works in question were not carried out "in the courtyard of the only Jew from Caransebeş" as you stated, but of the Synagogue of Caransebeş which, in addition to the role of place of worship, is a cultural pole in Caransebeş Municipality. Before the pandemic began, the synagogue was visited annually by hundreds of people, and was also the place where cultural events such as concerts, exhibitions, book launches were constantly organized - all of which were open to the general public without any participation fee. On the occasion of the Jewish New Year (September 20), the synagogue hosted dozens of people, both Jews and non-Jews alike, and we would like to mention the many classical music concerts brought musicians from prestigious cultural institutions from Romania, Germany, Israel, Austria, etc.
- At the same time, we would like to mention that in Romania the cults are equal before the law and the public authorities, according to Art. 9 of Law 489/2006: (2) The cults are equal before the law and the public authorities. The State, through its authorities, will not promote or favor the granting of privileges or the creation of discrimination against any cult. 3. Public authorities shall cooperate with and support activities in areas of common interest. (4) The Romanian State, through the competent public authorities, supports the spiritual-cultural and social activity abroad of the cults recognized in Romania.
